Terms of Agreement

1. Party fees include payment for use of the upstairs deck and pool entry for all party guests during the party time frame. If it is determined that additional lifeguards are needed due to the timing and/or size of the party, the host may be responsible for additional lifeguard fees.
2. Party duration is limited to ½ hour of set up, ½ hour of clean up, and 3 hours of party time. Additional hours may be available at an additional \$50/hour.
3. Rental fees are due at the time of booking. Please make checks payable to MSCSC and mail your fee and form to Amanda Kolling (address to be provided via email).
4. Only members may book and host a party. Members may not book a party on behalf of a non-member.
5. Member is responsible for leaving the utilized party areas in a clean condition and must place all trash (including all decorations, balloons, paper goods and food) in the dumpster (not trash receptacles). Lifeguards are not responsible for cleaning up after parties.
6. No private parties are permitted Memorial Day weekend, Juneteenth, July 4th, or Labor Day weekend.
7. It is the member's responsibility to make sure all guests comply by the following rules as well as all rules posted at the pool:
 - a. All guests must follow the swim test rules: Children 10 years old and under, or at the guards request, may use the deep end and diving well after they pass a basic swim test which includes starting at one end of the pool, swimming halfway across the width of the pool, pausing to tread water for 30 seconds and then completing the lap

to the other wall without assistance. Non-qualifiers will be restricted to the training/shallow end of the pool.

- b. No unseemly or disturbing noise or any illegal or immoral conduct to obstruct or interfere with the rights, comforts or convenience of other occupants of the pool or neighbors. Members and his/her guests must abide by Montgomery County Noise Ordinance.
- c. Use of tobacco products is prohibited and no illegal drugs shall be brought into, or consumed within the pool grounds.
- d. Each guest under age 12 must have a parent or guardian in attendance to supervise at all times, including in the pool, on the pool deck and picnic areas, and on the basketball and pickleball courts.
- e. If the swimming pool is closed during any portion of the party for non-weather related issues, you may be entitled to a refund of a portion of the Fee. If the member cancels with less than 24-hour notice, fees will not be refunded.
- f. Steps, walkways, pool decks, etc. can be slippery when wet. Member agrees to use extreme caution and to so advise guests.
- g. No glass, china, bottles, or anything breakable may be brought into, or used within, the pool area at any time.
- h. MSCSC shall not be liable for any injury, damage or loss to person or property caused by member, or member's family, agents, guests, or invitees or other persons, or caused by theft, vandalism or other causes, unless the same is exclusively due to the omission, fault, negligence, or other misconduct of MSCSC. Member agrees to indemnify MSCSC and save it harmless from and against any and all claims, actions, damages, liability, and expense in connection with loss of life, personal injury and/or damage to property during the Term arising from, or out of, any occurrence in, upon or at the MSCSC property or the use by member of MSCSC or occasioned wholly or in part by any act or omission of the member, its agents, family, guests or invitees. Furthermore, member agrees to pay MSCSC for all damages to the Amenity caused by misuse, waste or neglect by the member, its family, agents, guests or invitees.
- i. Lifeguards from the pool management company, who hold current lifesaving/water safety certificates, standard first aid certificates, and cardiopulmonary resuscitation certificates, will be in attendance at the swimming pool. The lifeguards are responsible for the enforcement of all pool rules and regulations, and are authorized to close the swimming pool at any time and to require any person(s) to leave the swimming pool.
